

Topoint Reports 2025 02 Financial Results

25Q2 Revenue & PAT Reached NT\$1,013M & NT\$78M Respectively with EPS of NT\$0.55

Taipei, Taiwan, Aug. 8th, 2025 – Topoint Technology Co., Ltd. (Topoint, TWSE: 8021) announced its financial results for 25Q2, which ended on June 30th, 2025.

25Q2 revenue and profit after tax were NT\$1,013 million and NT\$78 million respectively while basic after-tax earnings per share came in at NT\$0.55.

The 25Q2 results, when compared to 25Q1 and the same quarter a year earlier, were as follows:

- Net revenue increased 14.1% QoQ to NT\$1,013million from NT\$887 million in the previous quarter and increased 13.8% YoY from NT\$890 million in 24Q2.
- For Gross profit increased 30.2% QoQ to NT\$298 million from NT\$229million in the previous quarter and increased 26.4% from NT\$236 million in 24Q2.
- P Operating income is NT\$141 million and increased 94.7% from NT\$72 million in the previous quarter and increased 74.7% from NT\$81 million in 24Q2.
- Net income attributable to shareholders of the Parent is NT\$78 million and increased 51% from NT\$52 million in the previous quarter and increased 15.7% from NT\$68 million in 24Q2.
- Earnings per share of NT\$0.55 based on weighted average outstanding shares of 142 million.

All figures were prepared in accordance with TIFRS on a consolidated basis.

A breakdown of 25Q2 revenue by product categories shows PCB drills 64.5%, followed by drilling service 35.5% of total revenue.

114 年第二季合併營業收入 10 億 1 仟 3 佰萬元, 稅後純益新台幣 7 仟 8 佰萬元,每股稅後盈餘為 0.55 元

尖點科技股份有限公司(股票代號:8021)於今(8)日公佈114年第二季會計年度截至6月30日之財務報告。第二季合併營業收入為新台幣10億1仟3佰萬元,稅後純益為新台幣7仟8佰萬元,每股稅後基本盈餘0.55元。說明如下:

- 第二季營業收入淨額為 10 億 1 仟 3 佰萬元,較第一季的 8 億 8 仟 7 佰萬元增加 14.1%, 較去年同期的 8 億 9 仟萬元增加 13.8%。
- ▶ 第二季營業毛利為 2 億 9 仟 8 佰萬元,較第一季增加 30.2%,較去年同期增加 26.4%。
- ▶ 第二季營業利益為 1 億 4 仟 1 佰萬元,較第一季增加 94.7%,較去年同期增加 74.7%。
- 第二季歸屬於母公司業主之稅後淨利為7仟8佰萬元,較第一季增加51.0%,較去年同期增加15.7%。
- ▶ 依目前加權平均發行股數計算,第二季每股稅後基本盈餘為 0.55 元。

在銷售組合方面,第二季 PCB 鑽針佔合併營收 64.5%;鑽孔服務則佔 35.5%。
